Chair's Report

Shirley reported she attended the Faculty Senate meeting. She also attended New Student Orientation to represent Staff Council's student retention efforts. She enjoyed talking with incoming students and their families.

She recently attended the Hall of Fame selection committee meeting. They review athletes, staff and administrators. Once they have made their selections, those names are given to the Athletic Director who makes the final decision.

She participated in the in-person interviews of candidates for the AVP of Talent and Culture. Thea had attended a few when Shirley was not able to.

Advisory Council of Classified Employees (ACCE) Report

Jodi reported they discussed the pay scale and went over committees in preparation for their July meeting during which they will elect the new officers. They also talked about classified and non-classified staff numbers across the state.

They are looking into more training on non-classified staff, which is listed under state code 18b 9a-2 and will discuss further during their July meeting.

Two students were elected to serve on the ACCE – Madison Santmyer from WVU and Walker Tatum from Marshall University. One of the several items of concern is textbook affordability and another is communication between students and faculty. They also plan to present to WV Council for Community and Technical Colleges on Education; the Senate Education on Hunger Free Campus Act; Chancellor Tucker and Vice Chancellor Turner of the HEPC; the classified faculty and classified staff; the Student

Success Summit that is going to be held in mid-July; the Student Voice Panel; and the SGA Alumni Panel for WV Student Leadership Conference.

Board of Governors (BOG) Report

Shirley reported she met with the Ad-hoc Governance Committee to present the nominees for the Presidential Search Committee. The Staff Council representative is Joan Crabtree.

She serves on the BOG nominating committee for selecting the individuals who will be the chair, vice chair and secretary. They have selected the candidates and presented it to the BOG. Their appointments will begin in July.

Their June 20th meeting was their retreat and the June 21st meeting they approved several items:

- a new undergraduate certificate program in Mine Safety Practices and Health in the Statler College of Engineering and Mineral Resources;
- the termination of the PhD in Education within the College of Applied Human Sciences;
- the online graduate certificate in the School of Physical Activity and Leadership;
- Sport Industry Leadership and Change Management;
- Advanced Sports Management Research;
- Athlete Talent Identification and Development;
- Athlete Empowerment through Positive Coaching;
- Applied Sport Sciences and Coaching within the College of Applied Sciences;
- the undergraduate and graduate program reviews recommendations;
- Tuition increases for undergraduate students \$228 increase per semester and \$624 increase for non-residents;
- Tuition increases for graduate students \$252 increase per semester and \$639 for non-residents

- The Campus Self-Defense Act ensuring state higher education institutions are implementing that new legislation with full staff input
- The market study that is under way at the HEPC and ACCE
- How to include non-classified staff concerns with shared governance

- Outcomes based funding at the state level and how it might affect our institutional stability and sustainability going forward
- The legislation that is introduced during each legislative session that affects higher education as well as any rules or policies that are out for public comment
- Our unity agenda faculty and staff concern about PEIA increases and defending DEI initiatives
- The Hunger Free Campus bill
- Textbook affordability
- Supporting student efforts in raising awareness to the legislature of the issues that keep young people from staying here
- Engagement with our Staff Councils

Student Retention

Old Business

The feedback from Staff Council members on what attributes they would like for the new president of WVU was received and narrowed down. That is set to go out to classified staff on August 5-9 and August 12-16 with a reminder on August 14^{th.}

New Business

Shirley shared she received an email from an employee expressing concern about WVU Up All Night and the campus carry bill that goes into effect on July 1. She forwarded it to Travis Mollohan, Associate Vice

President, Corporate and Government Relations, and Corey Farris, Associate Vice President and Dean of Students, Student Life. They will reach out to the individual to address his concerns.

Jodi had shared information about the pump act that only affects staff who clock in and out. Shirley shared that President Biden signed the Consolidated Appropriations Act 2023 into law on December 29, 2020. The law includes the pump for nursing mothers act called the Pump Act which extends to more nursing employees the right to receive break time to pump in a private place at work. Talent and Culture and our legal team are working on language concerning guidelines and guidance on the Department of Labor's Pump Act. At WVU, it is currently maintained by the Women's Resource Center. Sarah added employees are encouraged to talk with their supervisors. Sarah offered to provide any suggestions or language from Staff Council to Michael Spooner on our legal team.
